Program **Overview**



Each year, 10-25 sophomores are selected as Kenan Scholars. These students are recognized for their superior scholarship and genuine interest in putting the private sector to work for the public good. Scholars are introduced to the critical role that business plays in identifying and providing sustainable solutions to complex contemporary issues.

Scholars are mentored by academic and industry thought leaders, business executives, serial startup entrepreneurs, policymakers, government officials and Kenan-Flagler Business School alumni. Scholars develop competencies in leadership, research and cross-sector collaboration that are essential for their success as future business leaders.

Scholars receive individualized guidance from a dedicated Kenan Scholars advisor, research direction from Kenan-Flagler faculty researchers and financial support for professional development tailored to their interests. Scholars also have access to the resources of the Kenan Institute, which include invitation-only conferences and forums, as well as connections to the Kenan Institute's affiliated centers.

The Class of 2020 Kenan Scholars will be remembered for their numerous awards and recognitions, coupled with impressive leadership accomplishments and research endeavors.



Tai Huynh was the first Vietnamese-American elected to North Carolina public office last fall and continues to serve as a member of the Chapel Hill Town Council. Among Kenan-Flagler's ten honors candidates, nine Kenan Scholar graduates completed their senior honors thesis with honors, with three scholars further distinguishing themselves by earning highest honors. To recognize Kenan Scholar's outstanding research accomplishments, the inaugural John Kasarda Research Excellence Award was established.

Two graduates are returning to academics: one pursuing a Master of Accounting degree at UNC-Chapel Hill, the other entering the Darden Business School's MBA program at the University of Virginia. Other graduates of this class have begun their professional careers representing a variety of leading firms, including Aetna, Capital One, Credera, EY and Wells Fargo.

This incredibly talented group of Kenan Scholar graduates is furthering their commitment to changing the world for the better in business, academia and government.

The first cohort of Kenan Scholar alumni (class of 2019) is composed of 10 Kenan Scholars who have played an instrumental role in the Kenan Scholars program and its development. With their pioneering spirit, our alumni continue to make great impacts beyond Kenan-Flagler. Two alums are pursuing advanced degrees: one in a Master's program at Universita Bocconi in Milan, Italy and the other right here at UNC-Chapel Hill, completing his medical program. Three more alumni are in Georgia, working in marketing at The Link Group, BrightHouse and Levolor. One alumnus, Jack Amoroso, based in Austin, Texas, has been contributing to Parthenon Capital Partners as an analyst since graduation.

Alum Spotlight featuring Jack Amoroso '19

Since my graduation last spring, I have been working at a private equity firm in Austin, Texas. I enjoy both my work and Austin

I continue to stay in touch with the Kenan Scholars program staff and stay attuned to Kenan Scholars news. I hear about the awesome work from new classes of Kenan Scholars, and I can tell that the bar is raised each year, particularly in research. Reflecting on my own experience, I can confidently say that writing an honors thesis as a Kenan Scholar was



one of my most rewarding decisions at Carolina. My honors thesis examined how changes to Medicare and Medicaid affect healthcare company valuations. It was a crash course on the U.S. healthcare system, its history and its often-dysfunctional nature today.

But I did not research the thesis alone. I had the support of the Kenan Scholars program, my faculty advisor, Kenan-Flagler professors and, perhaps most important, a group of Kenan Scholars by my side. In what other setting on campus can three students

—equally passionate about their field of research — discuss North Carolina renewable energy, the effects of global banking on capital reserves, and the challenges of the U.S. healthcare system?

I hope current Kenan Scholars leverage their alumni networks (and mature into great alumni ambassadors themselves), but also make the most of their unique opportunity to do research alongside some of the most qualified and curious students at UNC. Writing a thesis can be a lonely endeavor; as a Kenan Scholar, it doesn't have to be.

Donor Thank You & Spotlight

Luther Hartwell Hodges Jr. '57

Kenan Scholars Program Director Kim Allen sat down with Luther Hodges Jr. for a sociallydistanced conversation about Hodges's philosophy of leadership and commitment to public service, two hallmarks of the Kenan Scholars program.



As a banker, public servant, North Carolina native and former member of the University of North Carolina System Board of Governors, Luther Hodges has made investing in UNC Kenan-Flagler Business School a priority.

Luther received a Bachelor of Arts in economics from UNC in 1957, and a Master of Business Administration from Harvard Business School in 1961. At the urging of Rollie Tillman, then Kenan-

Flagler professor of marketing, Luther returned to UNC as a research associate and taught corporate finance. In 1968, he and Tillman co-authored the book "Bank Marketing," which changed the face of banking.

From 1962 to 1977, Luther worked at what later became Bank of America, rising to board chairman. He went on to a career of high-ranking positions in banking and government. In 2016, he published "Bank Notes," on the rise of banking in North Carolina and the 1990 failure of The National Bank of Washington.

On Leadership

Luther believes in teaching leadership by example, and stresses the connection between leadership and ethics, saying that "it's hard to tell where one stops and the other begins." He adds that leaders must be engaged and accountable. "You have to know what is going on and deal with it hands-on, not just superficially," he says. "You can't tell people to work hard if you don't work hard yourself."

Commitment to Public Service

Luther attributes his development as a leader to two influences — his father and his time in the U.S. Navy. Luther H. Hodges Sr. was secretary of commerce under the Kennedy and Johnson administrations and the 64th governor of North Carolina. Although his son lost his 1978 race for the U.S. Senate, he became the first U.S. deputy secretary of commerce under the Carter administration.

Luther's advice to those who aspire to leadership? Hard work and service. And, he adds, "Don't be too comfortable."

Kenan Scholars Board of Mentors



The Kenan Scholars Board of Mentors is a select group of business leaders, near-peers, policymakers and UNC Kenan-Flagler faculty who provide professional guidance to the Kenan Scholars in one-on-one and group sessions. Each junior class of scholars is assigned its own board that participates in moderated panel discussions and networking. Scholars are also assisted in reaching out to mentors for individual professional guidance. Mentors commit to serving for one year, with the opportunity to engage with scholars through their senior year.

Research

Scholarly Research in Business

Research is a signature component of the Kenan Scholars program. It drives innovation and is critical to conducting business in today's data-driven economy. Employers are looking for leaders who can solve problems, think critically, interpret data and communicate findings clearly and plainly to a variety of audiences. During their senior year, Kenan Scholars work closely with Kenan-Flagler faculty to explore cutting-edge issues in business. Scholars acquire knowledge and skills in three competency areas: research methodology, information and data literacy, and communication of research findings.

With a goal to move basic research discoveries quickly and efficiently into practice, Kenan Scholars are supported in producing translational research products.

Celebrating Undergraduate Business Research

The Kenan-Flagler Business Research Expo is a research symposium held at the school each April. It is a new partnership between Kenan Scholars and the Undergraduate Business Program at Kenan-Flagler Business School. The goal of the



expo is to showcase and encourage student research in business, and it provides an opportunity for all Kenan-Flagler students to meet potential faculty advisors and learn about research opportunities at the school.

Because of COVID-19 concerns, the 2020 inaugural in-person Kenan-Flagler Research Expo was cancelled. However, our online virtual Kenan-Flagler Business Research Expo featured abstracts, posters and theses of the 2020 Class of Kenan Scholars.

Scholars can choose to work on an independent research project under the supervision of a Kenan Institute-affiliated center, or for those who are eligible, graduate with honors by successfully completing a senior honors thesis.

In an effort to further strengthen the research capabilities of our students and prepare them for their senior research, the Kenan Scholars program offered a Research Workshop Series throughout the 2019-2020 academic year. Some sessions included panels of Kenan-Flagler faculty, while others were presentations from campus partners that support student research. The topics covered follow

Senior Honors Thesis



Although the first affordable housing program in the U.S. began in 1917, America still faces a significant shortage of affordable housing today. The shortage disproportionately affects low-income workers who cannot afford to live near their jobs and face growing commutes. In order to mitigate the worsening effects of the shortage on lower-income workers, nongovernmental organizations are increasingly engaged in workforce housing development. This research draws on the extant literature, key informant interviews and surveys of affordable housing experts, and case studies of actual workforce housing development projects to create a set of "promising practices" that colleges and universities can deploy to develop much-needed workforce housing for some of their employees.

While the number of women in the workforce continues to increase, research suggests their mere presence does not necessarily equate to influence within organizations. Research also highlights a culture of psychological gender inequity which permeates many organizations. My research aims to build on this foundation of gender inequity research by linking early career "token" status to future career decision-making. To do so, I developed a survey targeting young professionals (5-10 years out of college) that assessed gender inequity measures (tokenism, "bro" culture, acceptance, inclusion, etc.) in connection with future career trajectory decisions (planned pivots, gender consideration of new organizations, industry switches, etc.). The objective of my research is to identify linkages between these two areas that may increase our understanding of potential best practices for further developing an inclusive organizational culture.

Through my research, I found that women in male-dominated fields were more likely to consider the gender balance of their new teams when changing jobs, compared with women in more balanced gender environments and males in male-dominated fields. Furthermore, I found that gender makeup predicts gender balance preferences through the experience of tokenism.



Although many call the United States "the land of opportunity," recent research suggests the country does not provide the level of opportunity that many imagine it to have. Research related to the underlying factors behind this lack of opportunity revealed that economic mobility in the United States is affected by residential segregation, income inequality, school quality, social capital and family stability. To date, researchers in the United States have yet to explore the potential impact of entrepreneurship — known to be a promoter of economic growth, job creation and wealth accumulation — on economic mobility, despite a vast body of international literature surrounding the mobility-entrepreneurship and economic mobility in America by examining the relationship on a county level across the United States.

Should You Should Others: Sustainable Marketing's Impact on Brand Perception and Green Sportswear

Historically, the sportswear industry has paid little attention to issues of sustainability. However, today's consumers are increasingly incorporating sustainability into their purchasing decisions. Sportswear firms have begun to confront these converging realities with sustainable sportswear products. For these new products to maximally succeed, marketers must apply sustainable marketing best practices. This thesis provides a first look at developing these principles through the use of an experimental consumer perception survey featuring twelve unique stimulus advertisements varying across four brands and three constructs: utilitarian, sustainable assertive and sustainable gentle product claims. The findings of this research suggest that utilitarian claims, in comparison to sustainable claims, promote higher perceptions of sportswear product quality. Assertive claims exhibit a significant negative impact on consumers' willingness to recommend sustainable sportswear. Finally, the combination of brand, product and claim add a complexity to sustainable sportswear introduction that must be met with an intimate understanding of consumers.



The United States' position on trade and the Federal Open Market Committee's outlook both govern the pricing of equities, debt and other derivatives domestically and internationally. Unprecedented executive influence on trade and the Fed, coupled with a president's unpredictable and instantaneous communication on Twitter, inspired banks and trading firms to create indexes, bots and derivatives to account for this phenomenon. This thesis asks the question: How do President Donald Trump's tweets affect the broader stock market in terms of pricing and volatility? I use intra-day event study analysis on a sample of 2148 of the president's tweets to evaluate the market impact of general tweets. I segmented the tweets into Fed-related tweets, trade-related tweets and other tweets before evaluating the pricing and volatility impacts, using the SPX index and VIX index respectively. I found significant differences in the market reaction between trade-related tweets and Fed-related tweets and other tweets.


Social Media Marketing and the Performing Arts Industry: The Effect of Twitter on Broadway Ticket Sales

Elizabeth Lang Class of 2020

The integration of social media marketing into the Theatre District has shifted Broadway from a passive experience to a multi-dimensional dialogue. A Broadway show's cast and creative team now have the opportunity to connect with fans directly as well as release social media content to the public for further show enjoyment. What research has yet to address, however, is the extent to which an effective social media presence directly translates into increased ticket sales. My research explores this question by analyzing the effect an active Twitter presence has on weekly ticket grosses for six long-running Broadway shows. To examine this relationship, I first performed a series of difference-in-difference estimations to determine if simply creating a Twitter account affected weekly ticket grosses. I then went into greater depth and ran a multiple regression analysis to determine the extent to which volume of show-related tweets increased weekly ticket grosses. The results indicate that Twitter and the volume of tweets likely do not have a discernable impact on ticket sales.



Medicaid work requirements are a relatively new policy, coming into effect in January 2018. While the current literature focuses on coverage loss for Medicaid recipients, this honors thesis examines the impact of implementing Medicaid work requirements in North Carolina. I examine the effects of Medicaid work requirements on payer mix, operating margins and uncompensated care costs of disproportionate-share hospitals in North Carolina. Using a quantitative approach with hospital data from the Centers for Medicare and Medicaid Services, this study concludes that work requirements significantly affect payer mix, operating margins and uncompensated care costs. The results indicate that work requirements could decrease the Medicaid payer mix by 2 percent at hospitals. Additionally, my research suggests that operating margins improve 1.8-2.0 percent, while uncompensated care costs increase 3.3-3.4 percent. The results indicate that, while hospital margins could improve with work requirements, the increases would be outweighed by the increases in uncompensated care costs.

Advisor: Professor Saravanan Kesavan Does Gender Diversity Impact Firm Performance? An Examination of Law Firms and Revenue Earned

The topic of gender and law firms is becoming increasingly important as the number of women graduating from law school continues to rise. Concurrently, large, influential companies are demanding increased diversity in their legal representation. Building on prior research pertaining to gender diversity, I explore the relationship between gender diversity and business performance of law firms, specifically exploring whether gender diversity within a firm affects the amount of revenue generated by the firm. Using linear regression analysis, I explore the relationship between the percent of female employees and percent of female partners within a law firm and the annual revenue growth rate experienced by the firm. I explore the influences of headquarter location, national versus regional scope and firm age on the relationship between gender diversity and law firm performance.



Recent studies highlight females' positive impact within the business world and entrepreneurial ecosystem. Within the entrepreneurial ecosystem, however, females lag behind their male counterparts in funding accumulation. Previous research identified three primary causes to this discrepancy: lack of females in the financial capital industry, implicit bias and female- versus male-owned company characteristics and owner attitudes. What isn't addressed, however, is an analysis of the industries pursued by females versus males. My study identifies and attempts to understand underlying causes in gender funding differences based on industry. I use a mixed-method approach of quantitative and qualitative analysis. My findings suggest that industry does not exhibit a significant role in gender funding differences, implicit bias continues to plague females and females are underrepresented across all industry lines. Females receive fewer investment dollars than their male counterparts, appearing to directly correlate to the limited number of females entering the entrepreneurial ecosystem. Research

We are pleased to report that our graduating scholars (Class of 2020) have successfully completed their senior research. Of the ten honors thesis projects completed by Kenan-Flagler undergraduate students this year, nine were by Kenan Scholars, with three recognized with highest honors. Scholars' research covered a wide variety of business issues, including economic mobility, affordable housing, sustainability, Medicaid and gender diversity.

Impactful **Programming**

A key component of the Kenan Scholars is programming, as we offer many events for our scholars to develop as professionals, engage with business and community leaders, strengthen research and networking capabilities. and recognize achievements. Affordable Housing Symposium

On Friday, November 22, 2019, the Kenan Scholars co-sponsored the Investing in Affordable Housing Symposium in collaboration with the Wood Center for Real Estate Studies. This half-day symposium explored the production and preservation of affordable housing in the Triangle and beyond.
